## Junior Developmental Volleyball

The Montana Juniors VBC will begin its twentieth season with tryouts on Sunday, Feb. 28th at **Elysian JH & Senior HS**. Teams will be formed in four age groups: U-18's (Grades 11-12), U-16's (Grades 9-10), U-14's (Grades 7-8), and U-12's (Grades 5-6). The 16's & 18's will try out at Elysian JH at 1:00 pm. The 12's & 14's will try out at Senior HS at 5:00 pm. Check-in will begin 30 minutes prior to the start of the tryout.

They will be evaluated while performing drills and in competition. Notification of making a team will be done at the completion of the tryout. Each team will generally have 10-12 players.

Practice times for all age groups will generally start anywhere from 4:30 to 6:30 and run two hours. The first practice begins the week after the tryout. Locations and specific times will be announced once the teams are selected. The season is twelve weeks long, with teams competing primarily at tournaments in Montana, although there is a possibility of going out of state (WY/ID).

The cost for the club is \$350\*. This covers coaching, gym rental, equipment, uniforms, and tournament fees. Not covered are travel costs and the AAU fee.

Please try to send in your registration prior to the tryout if possible though we will accept those that walk-in. Bring all that you need (knee pads etc.) and prepare yourself (any taping, etc.) prior to the start of the tryout.
